(L) Continuous disrespect for Holy Entities, Names, Powers and Authorities;  
(M) Continuous disrespect for Holy Entities, Dominions and Domains;  
(N) Continuous disrespect for Powers of the Great Elements;  
(O) Continuous disrespect for Essence of Planes of Heaven;  
(P) Continuous disrespect for Essence of Depths of Hell;  
(Q) Continuous disrespect for Spiritual Attitude with respect to Invocations of Testimony;  
(R) Continuous disregard of Circle of Invocation conduct;  
(S) Continuous disregard of Circle of Invocation procedures;  
(T) Continuous disregard of Training Session content;  
(U) Continuous misconduct;  
(V) Continuous disobedience of Orders.

SENTENCE UPON CONVICTION:

**To be permanently and forever barred and restrained from any and all further attendance, counsel, instruction and training of this Holy Order and any and all tithes, gifts and offerings whatsoever therefrom shall be refused. Only The Most High can determine repentance.**

### **GENERAL RULES OF THIS HEARING:**

(01) The Senior Colonel Presiding shall maintain order without exception and decisions of the Senior Colonel Presiding with respect thereto shall be final.

(02) The Senior Colonel Presiding and Judges of the Hearing are authorized to question any Subject, Witness, Officer of the Hearing and to examine any and all evidence presented; and to authorize the Chief Clerk, Recording Secretary and/or any member of their relevant Staff to question any and all personnel and presentations before the Grand Council with respect to matters of clarification.

(03) Hearings before the Grand Council are open to all Akurians regardless of Rank, Grade or Station including neophytes in training.

(04) There shall not be any interruption whatsoever of the Voice of the Floor except by the Senior Colonel Presiding and/or Command Senior of the Hearing who may Rule even without objection.

(05) There shall not be any intrusion of comment nor presentation of evidence except by and upon direction of the Senior Colonel Presiding.

(06) Comments of and by Officers of the Grand Council of Gnostics shall be deemed to be evidence until proven false; comments of Officers for the Prosecution and Officers for the Defense shall not be considered evidence; comments of the Subject and all witnesses shall be considered to be evidence.

(07) The Subject shall be permitted to retain counsel ; speak on their own behalf; examine and challenge any and all evidence presented against them; and present evidence in their defense.

(08) The Subject shall be permitted to retain Proven Knowers of The Great Testimony to Discern any and all Officers of the Grand Council of this Hearing, and any and all Personnel and evidences whatsoever and without exception presented before said Grand Council of Gnostics of this Hearing.

(09) Any and all Proven Knowers of The Great Testimony are authorized to discern any and all Officers and Staff of the sitting Grand Council of Gnostics of this Hearing, any and all Entities and Personnel with respect thereto, and any and all evidences and sources thereof; and any and all Discerning Proven Knowers so retained must present their findings to the Grand Council of Gnostics of this Hearing in open session at the Order of the Senior Colonel Presiding.

(10) Presentation of irrelevant and/or frivolous evidence will then and there constitute conviction of the Subject of all Specifications and Charges and such conviction shall forever be without appeal before the Grand Council of Gnostics.

(12) Presentation of false, altered, manufactured or otherwise created evidence shall then and there constitute conviction of the Perpetrator(s) of any and all relevant Statutes in and of Holy Law and shall then and there authorize the Grand Council to pronounce appropriate sentence thereupon.

**EVIDENCE PACKET WILL BE POSTED AND ALL RESPONDENTS NOTIFIED.**

## **GENERAL PROCEDURE FOR THIS HEARING:**

The Senior Colonel Presiding shall call the Hearing to Order.  
The Senior Colonel Presiding shall poll the Attending Muster.

**Recording Secretary of the Hearing, Command Marshal General D. Chylon Budagher, PK., shall present the Specifications and the Charges against the Subject and for the Akurians.**

**Chief Clerk of the Hearing, Command Marshal General Peter K. Shams-Avari, PK., present the opening statement for the Akurians.**

**Subject Dennis D. Sowell, attending member, shall be permitted to present the opening statement in his defense.**

There shall be no rebuttal to the opening statements.

The Hearing shall proceed.

The Akurian presentation first – evidences and comments of the Officers of the Hearing. The Subject must be permitted to object and question-in-turn any and all evidence presented.

The Subject presentation second – evidences and comments of himself and/or retained Discerning Proven Knowers of The Great Testimony. The Officers of the Hearing must be permitted to object and question-in-turn any and all evidence presented.

Only the Subject shall be permitted to present a closing statement.

The Senior Colonel Presiding shall poll the Judges of the Hearing in order of Rank and Station; Thus: "How say you, ..." Judges of the Hearing may not be interrupted by anyone other than the Command Senior of the Hearing for purposes of correction and/or clarification only.

**Recording Secretary of the Hearing, Command Marshal General D. Chylon Budagher, PK., shall present the Statement of Consequence to the Judges of the Hearing from the Manual of Discipline.**

Final Decision of the Judges of the Hearing must be unanimous for conviction and sentence as specified.
